Notes to the Financial Statements

As per regulatory provisions, a **guarantee fund** towards third parties (Article 13, paragraph 3 of the Statute) of 15.000,00 euros has been set up and involves the reserve of an unavailable and tied minimum assets as a guarantee for third parties which can establish relationships with the Association.

The relevant Italian regulations for recognized associations provide for a guarantee fund of 50.000,00 euros. The Statute of the Via Querinissima Association states for a gradual provision to reach this budget by saving 10% of the members' fees (Article 13 paragraph 3).

The **Association operates** through the direct participation of members in social activities and benefits from goods and services made available or financed directly by each member. These resources are valued economically according to the table below.

In addition, the resources that each member invests for **the direct promotion of events** connected to the Via Querinissima Association must be considered . (not quantified in this budget)

The **headquarters and utilities** are made available by the Veneto Region and do not constitute costs borne by the Association.
