Notes to the Financial Statements

As per regulatory provisions, an **endowment fund** (Article 13, paragraph 3 of the Statute) of 15.000,00 euro has been set up and involves the reserve of an unavailable and tied minimum assets as a guarantee for third parties which establish relationships with the Association. **This amount is set aside in view of the recognition of the legal personality.** The issue regarding the future of the Association awaits the outcome of the recognition of the CoE Certification. Then, the legal aspects of the organisation will be defined.

The relevant Italian regulations for recognized associations provide for an endowment fund of 50.000,00 euro. In order to reach the required amount, the Statute of Via Querinissima Association establishes a gradual provision of the fund, financed by 10% of the membership fees (Article 13 paragraph 3). The increase will be realised if the process of legal personality recognition will be carried out.

The **Association operates** through the direct participation of members in social activities and benefits from goods and services made available or financed directly by each member. These resources are valued economically according to the table below.

In addition, the resources that each member invests for **the direct promotion of events** connected to the Via Querinissima Association must be considered. (not quantified in this budget)

The **headquarters and utilities** are made available by the Veneto Region and do not constitute costs borne by the Association.
